I understand that Walkerville Primary School will:

- do its best to enhance learning through the safe use of ICTs. This includes working to restrict access to inappropriate, illegal or harmful material on the Internet, wireless network or on ICT equipment/devices at school, or at school related activities
- work with children and their families to encourage and develop an understanding of the importance of cyber-safety through education designed to complement and support the Use Agreement initiative. This includes providing children with strategies to keep themselves safe in a connected online world
- respond to any breaches in an appropriate manner
- welcome enquiries at any time from parents/caregivers/legal guardians or children about cyber-safety issues.

My responsibilities include:

- discussing the information about cyber-safety with my child and explaining why it is important
- supporting the school's cyber-safety program by emphasising to my child the need to follow the cyber-safety strategies
- contacting the Principal or ICT Coordinator to discuss any questions I may have about cyber-safety and/or this Use Agreement.

Dear Parent/Caregiver & Student,

The measures to ensure the cyber-safety of students at Walkerville Primary School are based on our core values. To assist us to enhance learning through the safe use of information and communication technologies (ICTs), we are now asking you to read this document and sign the attached Use Agreement Form.

Rigorous cyber-safety practices are in place, which include Cyber-Safety Use Agreements for staff and learners, who have been involved in the development of the agreement. Child protection education, such as the Keeping Safe Child Protection Curriculum, includes information about remaining safe when using new technologies and is provided to all learners.

The computer network, Internet and wireless access facilities, computers and other ICT equipment/devices bring great benefits to the teaching and learning programs at Walkerville Primary School, and to the effective operation of the school. The ICT equipment is for educational purposes appropriate to this environment, whether it is owned or leased either partially or wholly by the school, and used on or off the site. The overall goal of Walkerville Primary School is to create and maintain a cyber-safety culture that is in keeping with our values and with legislative and professional obligations. The Use Agreement includes information about your obligations, responsibilities, and the nature of possible consequences associated with cyber-safety breaches that undermine the safety of the school environment.

All students are issued with this Use Agreement and once signed consent has been returned to school, students will be able to use the school ICT equipment. Material sent and received using the network may be monitored, and filtering and/or monitoring software may be used to restrict access to certain sites and data, including e-mail.

While every reasonable effort is made by schools, preschools and DECD administrators to prevent children's exposure to inappropriate content when using the department's online services, it is not possible to completely eliminate the risk of such exposure. In particular, DECD cannot filter Internet content accessed by your child from home, from other locations away from school or on mobile or wireless devices owned by your child. DECD recommends the use of appropriate Internet filtering software.

## Strategies to help keep Walkerville Primary School Cyber-safe

Parents/caregivers play a critical role in developing knowledge, understanding and ethics around their child's safety and safe practices regardless of the time of day. Being cyber-safe is no exception and we invite you to discuss with your child the following strategies to help us stay safe when using ICT at school and after formal school hours.

1. I will use school ICT equipment only when my parents/caregivers have signed my Use Agreement form and the completed form has been returned to school.
2. I will use the computers, iPads, laptops and other ICT equipment only for my learning and only with my teacher's permission.
3. I will go online or use the Internet at school only when a teacher gives permission or an adult is present.
4. If there is something I'm not sure about, I will ask my teacher.
5. I will use the Internet, e-mail, mobile phones, smartwatches and any other ICT equipment only for positive purposes. Therefore, I will not be mean, rude or unkind to or about other people.
6. I will keep my passwords private.
7. If I find anything that upsets me, is mean or rude, or that I know is not acceptable at our school, I will:
  - not show others
  - turn off the screen
  - get a teacher straight away.
8. Only with written permission from home and the school will I bring any ICT equipment/devices to school. This includes things like mobile phones, iPods, games, cameras, and USB/portable drives.
9. I will ask my teacher's permission before I put any personal information online. Personal identifying information includes any of the following:
  - my full name
  - my address
  - my e-mail address
  - my phone numbers
  - photos of me and/or people close to me.
10. I will be careful and will look after all our school ICT equipment by:
  - not being silly and playing around with it
  - following our school cyber-safety strategies
  - telling a teacher about anything wrong or damaged.
11. If I'm not cyber-safe, the school may need to tell my parents/caregivers and there may be consequences associated with my behaviour.

## Walkerville Primary School Student Mobile phone and Device policy

Walkerville Primary School acknowledges that mobile phones and devices (iPads & Smartwatches) may be used as a safety measurement out of school hours for children who travel alone, on public transport or for those students who walk to school.

**Parents are reminded that in cases of emergency, the school office remains the vital and appropriate point of contact to ensure your child is reached quickly and assisted in any appropriate way.**

The decision to provide a mobile phone to their children should be made by parents or guardians. Parents should be aware if their child takes a mobile phone onto school premises.

**Please note**, the school accepts no responsibility for:

- Loss, damage or theft of mobile phones and iPad's while travelling to and from school and during the school day.
- Investigation of theft of phones. Students will be advised to report the theft to SA Police.
- The Department for Education does not provide insurance for accidental loss or damage to devices brought to schools for use by students. However, claims may be met under the department's public liability insurance where the loss or damage is attributable to a negligent act or omission on the part of the school.

### Acceptable Use

- Mobile phones are to be switched off during school time. Notifications are also to be switched off on smartwatches and iPad's.
- Mobile phones remain the responsibility of the student. They are to be handed to the teacher and locked in the classroom and are not to be taken into the school yard. Where a teacher accepts the responsibility to store them, they will be kept in a locked cupboard and returned at the end of the school day.

### Unacceptable Use

- Students with mobile phones and iPad's may not engage in personal attacks harass another person or post private information about another person using SMS, the internet, taking/sending photos or objectionable images and phone calls.
- Mobile phones or any electronic communication devices eg Smartwatches, iPads, etc. are not to be used to make calls, send SMS messages, surf the internet, take photos or any other application on school grounds.
- Students using mobile phones and iPad's inappropriately at school will face disciplinary action as sanctioned by the Leadership team. The school has the legal right and responsibility to hold a student's mobile phone or iPad to be handed to the SA Police if there are any concerns re inappropriate material on the phone or possible evidence of electronic abuse or harassment.
- Accessing the internet by using a mobile phone will be considered a breach of the school's code of conduct regarding BYOD and will result in access privileges to the school's computers being withdrawn.
